

TERMS AND CONDITIONS

DEFINITIONS:

Unless the context requires otherwise, the definitions used in this Agreement ("Terms and Conditions") shall have the following meaning assigned to them:

"Company" means Arcadian Trails Private Company.

"Program" means the set of activities and services offered, as expressed in the package named <u>"The 300 of Sparta" Epic March Sparta - Thermopylae</u> as such promoted by the "Company".

"Participant" means an athlete who has declared participation in the "Program"

"Associate" means the corporations or individuals that are acting in concert or on behalf of the "Company" under a special written agreement for that purpose.

THE SPECIFIC "PROGRAM" INCLUDES:

- Transportation inside Greece, by car or bus, as described in the "Program"
- Accommodation for 9 nights from Saturday May 5th, to Sunday May 13th, 2018 in Hotels on the axis of the route. Twin rooms will be used (i.e., double occupancy per room).
- Breakfast and dinner every day.
- Liquids, snacks and light lunch available throughout the march.
- Physiotherapist and first aid during the march.
- Full support by the members of the "Company's" Team during the March
- Daily briefing, in matters concerning the route.

IT DOES NOT INCLUDE:

- Tickets and other expenses to/from Greece.
- Transportation cost from/to the Athens Airport
- Hotel single room occupancy. In case required by the "Participant", it should be noted on the field provided in the "Declaration of Interest" and he/she will be informed by the "Company" on availability. The corresponding surcharge is 450 euro per person.
- Any kind of insurance coverage. "Participants" are required to have adequate personal and travel insurance coverage.

PERSONAL ITEMS – RESPONSIBILITY OF "PARTICIPANTS"

"Participants" are kindly requested to bring with them the following <u>labeled</u> bags:

• Travel bag with enough personal belongings to cover the entire period of their stay in the "Program", such as: clothing and footwear appropriate for the MARCH, raincoat with hood

underwear, personal care and hygiene items (toothbrush, toothpaste, razors shaving cream, etc.), socks, hat for the sun and whichever other associated item one might need (ex. foot cream, etc.). This bag will be transferred by the "Company's" team from one Hotel to the other.

• Lightweight individual backpack, which every "Participant" will bring with him daily throughout the course, with personal items and whatever one believes that is necessary in everyday life for his health and hygiene.

Responsibilities

- Transfer and/or use of drugs or other prohibited substances is strictly prohibited. The penalty of exclusion and expulsion from the program will be applied in this case.
- Outfits and symbols that contain or conceal messages of intolerance or racism, are challenging the aesthetics and/or are foreign to the historic route and the march are also not allowed.
- Finally, the organizing committee of the "Company" has the right to exclude or remove anyone who does not comply or obey to the general rules of the march, or of the "Program", without any compensation.

PARTICIPATION FEE

Participation in the "Program" requires the payment of a fee. The payment of this fee should be effected, as follows:

- A. 40% of the total amount, upon registration.
- B. The Remaining 60% to be paid <u>latest as indicated at the relevant section</u>.

Both payments should be made through one of the proposed procedures as set out at the end of the "Program". Such payment should be proved by the appropriate document of the "Company's" Bank (Eurobank)

Upon receipt of those payments (100%), the participation is registered as <u>"Finally Confirmed"</u> and "Participants" will be informed accordingly by the "Company".

Non-payment of any of the above installments, will exclude the "Participant" from participating in the "Program".

CANCELLATION

The "Participant" reserves the right to cancel his participation, two (2) months before the starting day of the "Program". In such a case, the "Company" withholds, as compensation, the 50% of the participation cost and returns to the "Participant" the remaining 50%.

In case cancellation is made within two (2) months prior to the starting day of the "Program", the "Participant" is charged with the 100% of the cost of the program. In case the participation is substituted and confirmed on time, then the total amount of money that the "Participant" has deposited to the "Company's" account, will be fully reimbursed.

In case of a "Participant" non-show, there will be no reimbursements whatsoever.

In case the "Participant" commences the program but, for personal reasons, interrupts or prematurely departs during the course of the "Program", he is not entitled to compensation or refund of any amount from the total "Program" cost, the only responsibility of the "Company" being to transfer the particular "Participant" to the City of Athens.

AMENDMENT OR CANCELATION

The "Company" is obliged to re-schedule, postpone or cancel the entire "Program" <u>before its implementation</u>, in case it deems that, due to "force majeure", governmental measures political unrest or strikes, the "Program" could be endangered or seriously complicated. In case the re-scheduling is not approved by the "Participant", the "Company" will refund to the "Participant" the total amount of money that has already collected. Any further claims by the "Participant" cannot be satisfied.

Finally, acting in the interest of the "Participant", the "Company" <u>during the implementation of the "Program"</u>, reserves the right to make any necessary alterations to the services to be rendered or to the "Program" itself, due to unforeseen circumstances that might occur during the course of the "Program" (weather conditions, traffic obstacles, etc.,) provided that these alterations will not substantially affect its overview and total concept. Furthermore, the "Company" is not responsible for products and services rendered to the "Participant" from third parties.

LIABILITY FOR INCREASED RISK

"Programs" like the present one, usually involve higher level of risk and thus, require the participating "Participants" to be in excellent physical condition and health.

The "Company" considers the "Participant" well aware of the nature of the dangers involved in the "Program" he participates and that he assumes his own responsibility for his choice. The "Company" the "Associates" and their staff will assist the "Participant" face any incidents in case of need, to the extent possible by the available infrastructure without out any further responsibility.

"Participants" have to sign the "Disclaimer" (waiver and release declaration), which is part of the present Terms and Conditions and deliver it to the "Company". This is necessary to be done by the "Participants" in order to be accepted and take part in the March. Participants can download and sign such declaration by clicking on the button Disclaimer at the field of registration.
